SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Burns: Flush with water immediately. While flushing, remove clothes which do not adhere to affected area. Call an ambulance. Continue flushing during transport to hospital.

Inhalation: Move injured person into fresh air and keep person calm under observation. If uncomfortable: Seek hospital and bring along these instructions.

Skin contact: Remove contaminated clothes and rinse skin thoroughly with water. In case of eczema or other skin disorders: Seek medical attention and bring these instructions.

Eye contact: Immediately flush with plenty of water for at least 15 minutes. Remove any contact lenses and open eyelids widely. If irritation persists: Seek medical attention and bring along these instructions.

Ingestion: Not likely, due to the form of the product. In case of ingestion: Aspiration hazard. Immediately rinse mouth and drink 1-2 glasses of water. DO NOT induce vomiting. Get medical attention immediately. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Immediately rinse mouth and drink 1-2 glasses of water or milk. Keep person under observation. Do not induce vomiting. If vomiting occurs, keep head low. Immediate transport to hospital. Bring along these instructions.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects: Dizziness. Headache. Coughing. Eye irritation. Dermatitis possible through repeated contact. Ingestion: Aspiration hazard. Nausea, vomiting. Be aware that symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure.

4.3. Indication of any immediate medical attention and special treatment needed

Medical attention/treatments: Treat symptomatically. If there is any suspicion of aspiration into the lungs either directly or as a result of vomiting, obtain medical advice.

SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing media

Extinguishing media: Extinguish with carbon dioxide or dry powder. Cool containers exposed to heat with water spray and remove container, if no risk is involved. Do not use water jet as an extinguisher, as this will spread the fire.

5.2. Special hazards arising from the substance or mixture

Specific hazards: Aerosol containers can explode when heated, due to excessive pressure build-up. During fire, gases hazardous to health may be formed.
